5. K12 Broadband Connectivity

The New Jersey Department of Education (NJDOE), in collaboration with the New Jersey Bureau of Public Utilities (BPU) Office of Broadband Connectivity, is participating in the National Telecommunications and Information Administration's (NTIA) Broadband, Equity, Access, and Deployment (BEAD) program. If accepted into the BEAD program, New Jersey intends to leverage federal funds over the next two years to subsidize fiber deployment to every public school in the state that does not yet have access to a 1 gigabit per second (Gbps) symmetrical connection.

6. New Federal Guidance Urges Expediting ARP-HCY Funds

The United States Department of Education (USED) recently released a Dear Colleague Letter to Chief School Officers urging states to expedite obligating American Rescue Plan Homeless Children and Youth (ARP-HCY) funds by September 30, 2024.

The New Jersey Department of Education (NJDOE) strongly encourages all school purchasing officials to enroll in the GovConnect notification system recently launched by the New Jersey Department of Community Affairs' Division of Local Government Services (DLGS).

8. Substitute Certification Service Limits

An LEA which employs an individual holding a substitute credential may request an extension of the service limit of 20 days for an additional 20 days, pursuant to N.J.S.A 18:16-1.1(a). Therefore, the maximum number of instructional days for an individual holding a substitute credential is **40 days**, in one classroom. Substitutes Webpage
